DESCRIPTION

Matador™ is a premium Brand of Spey Medical; a UK based pharmaceutical company headquartered in London and operating in more than 20 countries globally. Matador™ contains "Taurine 1000 mg" (a sulphur containing conditionally amino acid found in the heart, retina, brain, kidneys, blood vessels, intestines and skeletal muscles) which performs various biological roles like calcium modulation, immunomodulation, osmoregulation, bile salt conjugation, membrane stabilization and antioxidation.

INDICATIONS

Matador™ supplementation is believed to be beneficial in various etiologies:

- ✖ Diabetes and associated complications like nephropathy, neuropathy, retinopathy, cardiomyopathy, atherosclerosis and platelet aggregation
- ✖ Cardiovascular complications like hypertension, arrhythmias or congestive heart failure, hypercholesteremia and dyslipidemia
- ✖ Age related vision loss/age related macular degeneration
- ✖ Alcoholic and non-alcoholic fatty liver diseases
- ✖ Hepatitis, cystic fibrosis, liver cirrhosis
- ✖ Tinnitus, hearing loss
- ✖ Seizures & epilepsy
- ✖ Retinal dysfunction
- ✖ Anxiety
- ✖ Obesity
- ✖ Male infertility

DOSAGE AND ADMINISTRATION

One capsule 1-2 times daily or as prescribed by the physician

CONTRAINDICATIONS

Taurine is contraindicated in those hypersensitive to any component of a Taurine-containing nutritional supplement.

WARNINGS AND PRECAUTIONS

Pregnant women and nursing mothers should avoid Taurine supplements unless recommended by their physicians. Those with congestive heart failure should only use Taurine under medical supervision.

DRUG INTERACTIONS

✖ Lithium interacts with Taurine:

Taurine might have an effect like a water pill or "diuretic." Taking taurine might decrease how well the body gets rid of lithium. This could increase how much lithium is in the body and result in serious side effects. Talk with your healthcare provider before using this product if you are taking lithium. Your lithium dose might need to be changed.

USE IN SPECIAL POPULATION

Pregnancy and Lactation

There are no adequate and well controlled studies of this formulation in pregnancy. Should be used in pregnancy only if the potential benefit justifies the risk to the foetus. Caution should be exercised because it is not known whether any of the component of **Matador™** is excreted in human breast milk.

ADVERSE REACTIONS

Matador™ is possibly safe for adults when taken by mouth in appropriate amounts. Taurine has been used safely in adults in studies lasting up to one year.

OVERDOSAGE

In case of overdose, symptomatic and supportive treatment is indicated.

Store in cool, dry and dark place. Keep out of reach of children.
