Taurine: Taurine might have an effect like a water pill or "diuretic." Taking taurine might decrease how well the body gets rid of lithium. Talk with your healthcare provider before using this product if you are already taking lithium. Vitamin B6 (Pyridoxine): Reduces the effects of levodopa.
